



5. Electronic bids must be submitted to the office **Health Directorate, Hetauda** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or **12:00 Hr** on **8th Febraury ,2024(25 Magh, 2080)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00Hr 8th Febraury,2024(25 Magh,2080 )**. at the office of Health Directorate,Hetauda . Bids must be valid for a period of **90 Days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 184000.00 for Package 1 and 120000.00 for Package 2**, which shall be valid for 30 days beyond the validity period of the bid (i.e.8<sup>th</sup> ,June 2024)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
